Ticket purchase general terms and conditions for individual visitors and business partners:

*Admission for children aged 7 and under is free of charge.

**Family tickets apply exclusively to parents / legal guardians and their children aged 18 and under.

***Licensed tour guides for the Šibenik-Knin County are entitled to a free ticket upon presentation of a valid document.

****For groups of preschool and school children, prior announcement and authorised approval issued by the school/institution must be provided; otherwise group tickets and reservation will not be available.

*****Persons with disabilities and their escorts, retired persons and seniors (65+), students, Croatian Homeland War veterans and family members of deceased or missing Croatian Homeland War veterans are entitled to the listed price only if the ticket is purchased at the Information Centre of St Nicholas' Fortress or at the visitor information centre of the St Anthony's Channel upon presentation of a valid document.

*****Basic tours including the displayed content at the visitor information centre or at the location of the St Anthony's Channel, which take up to 1 hour, are realised for organised groups or individual visitors if they are previously announced by email, based on availability. Visitors will be charged an extra 20, 00 € / 150, 69 kn for every subsequent (initiated) hour. Guided tours are given in Croatian and English.

- The ticket is valid for a single visit to the visitor information centre, which is located in a naturally protected area, the Significant Landscape *Channel – Port*.

- The ticket price includes an optional use of multimedia equipment during the guided tour of the displayed content and visitor insurance.

- Visitors who present their individual tickets for the visit to St Nicholas' Fortress at the ticket office (the visitor information centre of the St Anthony's Channel or the information centre of St Nicholas' Fortress) will get a 20% discount on the ticket price for a visit to the visitor information centre of the St Anthony's Channel. The ticket must not be older than 30 days. Discounts are not cumulative.

- Visitors who present their individual or family tickets for the visit to the visitor information centre of the St Anthony's Channel at the ticket office (the visitor information centre of the St Anthony's Channel or the information centre of St Nicholas' Fortress) will get a 20% discount on the ticket price for a visit to St Nicholas' Fortress. The ticket must not be older than 30 days. Discounts are not cumulative.

- A group must comprise a minimum of 19 people. A group may comprise a maximum of 50 people for a basic tour that includes one tour guide. Organised groups must be announced in writing to the Public Institution Nature of the Šibenik-Knin County at least 24 hours prior to the scheduled visit time.

As to educational workshops and educational and interpretive walks, a group must comprise a minimum of 10 school children or adults, whereas a group may comprise a maximum of 30 school children or adults. A guided tour may be cancelled no later than 24 hours prior to the scheduled visit time. In case a group is not on schedule, provision of the service in question is not guaranteed.

- Tickets can be purchased through our webshop at www.kanal.svetog-ante.com, at the ticket office of the information centre of St Nicholas' Fortress at Obala dr Franje Tuđmana 4, 22000 Šibenik and at the visitor information centre of the St Anthony's Channel.

- A business partner is any business actor that has a regulated business relationship with the Public Institution Nature of the Šibenik-Knin County based on the Business Cooperation Agreement, in relation to organised visits to St Nicholas' Fortress and the visitor information centre of the St Anthony's Channel.
- As stated in the Business Cooperation Agreement, business partners are entitled to a 10% discount for the categories of prices listed in Points 1, 2, 4, 6, 7, 11, 12, 13, 14, 15 and 16 of the price list; they are also given a special discount if they duly fulfil their obligations under the Agreement and provide groups of visitors as follows: for a group of more than 100 visitors, a discount of 2% will be granted; for a group of more than 200 visitors, a discount of 4% will be granted; for a group of more than 300 visitors, a discount of 6% will be granted; for a group of more than 400 visitors, a discount of 8% will be granted; for a group of more than 500 visitors, a discount of 10% will be granted.
- Visitors who have purchased their ticket through our webshop can come to the visitor information centre with their ticket printed out. Taking a printout of the Print@Home ticket at the ticket office is not possible. If visitors are unable to print their tickets, they can use the barcode displayed on their smartphone as the purchase confirmation.
- All individual orders and purchases of tickets through our webshop are binding and final, and cannot be cancelled or amended. If the Print@Home ticket is not used, it is not possible to return it and claim a refund.
- The Public Institution Nature of the Šibenik-Knin County reserves the right to cancel the tickets for visits to the visitor information centre due to force majeure (technical malfunction of the displayed content or some other adverse circumstances in the normal operation of the visitor information centre). In this case, the Public Institution agrees to provide a refund for the payment amount.
- Tickets may not be copied, distributed, transferred, published or modified.
- All ticket prices are shown in euro and Kuna at a fixed exchange rate of 1 euro = 7, 53450 and are not subject to VAT in accordance with Section 90 of the Value Added Tax Act (Official Gazette of the Republic of Croatia 73/13, 99/13, 148/13, 153/13, 143/14, 115/16, 106/18, 121/19, 138/20, 39/22 and 113/22).
- The Manager of the Public Institution Nature of the Šibenik-Knin County may give an approval for the visits to the visitor information centre of the St Anthony's Channel with some benefits for visitors such as free or discounted tickets, which will be applied on specific days as occasions to mark particular events and at the request of individuals, groups, associations and/or institutions, for social reasons, for the purpose of promotion, education or the process of cooperation.

All the income received by the Public Institution Nature of the Šibenik-Knin County according to the above-mentioned prices will be used for activities carried out by the Public Institution Nature of the Šibenik-Knin County, for permanent protection, preservation and enhancement. The Public Institution Nature of the Šibenik-Knin County reserves the right to modify and update the prices during the year including the working hours of the visitor information centre.
